

#### **Intellectual Property Rights (IPR)**






#### INFRINGE<u>MENT</u>

- The definition of patent infringement may vary by jurisdiction, but it typically includes using or selling the patented invention. In many countries, a use is required to be commercial (or to have a commercial purpose) to constitute patent infringement.
- Typically, a party (other than the patentee or licensee of the patentee) that manufactures, imports, uses, sells, or offers for sale patented technology without permission/license from the patentee, during the term of the patent and within the country that issued the patent, is considered to infringe the patent.
- The scope of the patented invention or the extent of protection is defined in the claims of the granted patent. In other words, the terms of the claims inform the public of what is not allowed without the permission of the patent holder.
- Patents are territorial, and infringement is only possible in a country where a patent is in force. For example, if a patent is granted in the United States, then anyone in the United States is prohibited from making, using, selling or importing the patented item, while people in other countries may be free to exploit the patented invention in their country.

#### But what exactly does it mean to infringe on a patent?

- Lan you do it by accident, or is it always a malicious attack to steal something that doesn't belong to you?
  - Sometimes, the infringer knowingly tries to copy an existing product or process, perhaps with a minor modification to make it seem different enough to be considered a new invention.
  - This comes down to a question of equivalency, which the Supreme Court defines simply: "If two devices do the same work in substantially the same way, and accomplish substantially the same result, they are the same, even though they differ in name, form, or shape"





### Importance of Evidence of Use Chart

Evidence of Use (EoU) is a type of analysis designed to protect the IP and related interests of patent holders and investors. Its primary goals are to identify products, processes, or services in the marketplace that potentially infringe on the patent in question and to evaluate the strength of the patent assertion campaign.

▲ Determining and measuring the scope of infringement is essential for future litigations, royalty earning purposes and licensing opportunities.

If you are selling patent assets, proof of patent infringement can assist strengthen the terms of the sale.





#### Logic and common sense

- If the terms used in the claims are non-general then its better to define them first. Look for the definition in the patent's description itself otherwise get it from any other authentic source. This helps you to establish the correct sense of understanding and also supports the evidences in better way.
- 🚣 In this case we used the definition of 'hybrid operating room' from 'Emergency Care Research Institute' website.

#### Logic and common sense

- Logical thinking is more important than technical knowledge
- A The below screenshot is the best example to get a sense that logical thinking is the key in the infringement analysis.
- Most of the hospitals don't disclose much of the information on their websites, so in this case the screenshot is captured from the official website of the hospital which shows a door name plate that reads 'operating room #2'. From this it can be concluded that the hospital has at least two operating rooms, thereby fulfilling the criteria of multiple hybrid operating rooms.



Knowing a building area is near impossible until and unless someone has access to its legal property document or measures it physically. So google map has been used to find the dimensions of the building to calculate the approximate built area.



#### Another example

- In this example we need to find the capacity of the motor (or pump) which was not available in any public domain. But before that we need to proof there is an air pump.
- Capacity of the pump can be calculated in the three ways

Legal Advantage

- 1. Information available in the products datasheet or user manual
- 2. Testing (or reverse engineering) the product to find the ratings of the pump
- 3. Take a container of known volume and calculate the time pump takes to fill the container. Volume of the container divided by time will give the approximate capacity (or flow rate) of the pump (or motor).

- As there was no information available in product data sheet (or user manual) and at the same time the product was not physically accessible so all the three options are not helpful in finding the capacity of the motor.
- And here also logic comes to the rescue. Information related the balloon was available from an online shopping web portal.

  In the next step the product review videos were searched online.



So the total volume of the balloon will be $V = 216.86$ inch (taken $r = 2.45$ inch and $h = 11.5$ inch) which when converted into litres equals to $V = 3.55$ litre.

From the product review video found online, the time was noted at which the reviewer switched on the pump and the time at which it was switched off. The difference between these two readings would give the time taken to fill the balloon.



Losing the time calculated and the volume of the balloon, the approximate flow rate of the pump has been computed.



In this example, infringement was proved using the officially available data along with educated guesses and logical assumptions.

#### No room for error

#### One minor error is enough to shift the whole argument

an adapter to convert power from a power source, external to the adapter, to DC power for powering an electronic device, the adapter including circuitry for producing an analog data signal for use by the electronic device to control an amount of power drawn by the electronic device; and

A power source provides electrical energy and it may be alternating current (AC) or the direct current (DC). An adapter converts the given electrical power to DC power for use with electronic devices. The adapter includes an additional circuitry which regulates and controls output power and maintains constant and uniform voltage or power, as it is a mandatory, for the electronic device being charged. The electronic device draws this controlled power from the adapter.

An analog signal provides information about the power output level of the adapter at it outlet sends this signal to the electronic device. In case of the data transfer between two electronic devices the analog signal share the information between the two the electronic devices being connected.

The screen shot below shows the Apple's lighting charger's adapter.

- In this case it is United States. In the previous slide, it can be noticed that the iPhone adaptor shown as evidence is generally used in Asia and Europe but not in US.
- Instead, the adaptor shown in the image below should have been used as evidence as this is used in US.


